All information, from PLAINTIFF to the end of the page, must be included on the NOTICE OF SHERIFF SALE form. Note that the Sheriff does not provide certified mailings.

All Sheriff Sale fees must be paid at the time of filing. Make the check payable to VANDERBURGH COUNTY SHERIFF. You must provide a separate check for each parcel.

Compute the fee as:

Sheriff Sale fee	\$125.00
Defendant	\$10.00
Each additional defendant	\$3.00

All other governmental fees (liens, taxes, etc) must be paid prior to the sale.

The Evansville Courier & Press requires that each attorney firm prepay for advertising.
